DOUBLE PARKING

A letter was read from Dr Abraham Tamis, immediate Past President of the Bronx County Medical Society and a member of the Board of Trade, which asked us to urge the Police Department to favor double parking for doctors actually making professional calls.

After discussion no action was taken on this request.

ITINERANT STREET PEDDLING

The Board was advised that we were represented at the public hearing before the City Council's General Welfare Committee on January 6th, to urge the adoption of the so-called Kranis Bill to curb itinerant street peddling.

The Bronx Board of Trade and 30-odd civic organizations have been, for the past three years, attempting to get this bill introduced and passed. In effect it would bar all peddlers of general merchandise from major shopping areas. Moreover, the bill is designed to give the police greater strength in dealing with peddlers and the magistrates mandatory powers of imposing fines and even jail sentences where necessary.

Our Board has long approved this measure and this was in the way of a report that final victory in this effort is in sight. There are indications that the measure will soon be approved by the Council.

WEST FARMS LIBRARY

Mr Busher reported that the Board of Trade appealed to the National Production Authority for steel which has been allocated for the proposed West Farms Library. The site of the project in West Farms had been excavated and the job abandoned waiting for the The pit caused by the excavation was a dangerous nuisance and the Board received approval of its request to MPA and work on the Library was resumed this month.

SEX OFFENDERS

William T Whalen, retired Chief of Detectives in New York City, in a recent interview. drew attention to the serious problem of sex offenders and the lack of proper laws to cope with them. At that time Mr Whalen made a number of recommendations including physchiatric examinations for offenders and the need for institutional or clinical core.

He stated that under present laws, minor offenders can only be charged with disorderly conduct, given a small fine or a short termin in jail, even though they are picked up a thousand times. Under present laws they can't be compelled to take mental examination

After discussion, no action was taken by the Board on this matter. Instead, the opinion of Bronx District Attorney De Luca on the need for such legislation is to be south
